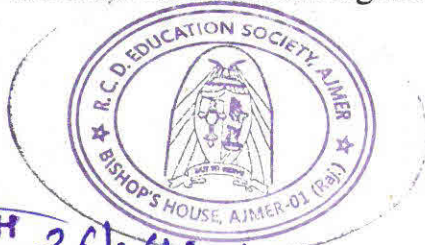

6. The school will not open classes under CTE name in any manner without a written permission.



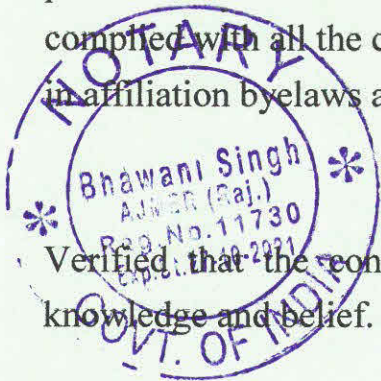

7.
